***Protection of Women and Domestic Violence Act, 2005.***

Department of English of Loknete Gopinathji Munde Arts, Commerce & Science College, Mandangad has organized a lecture on ***Protection of Women and Domestic Violence Act, 2005***. Dr. Subhash Sawant was the resource person for it. In his address he discussed the act and to identify and determine that every act of domestic violence is unlawful and punishable by law. To provide protection to victims of domestic violence in the cases such acts occur. He also explained the process of assigning justice to serve justice in a timely, cost-effective, and convenient manner to the aggrieved person. The major characteristics of this act are The Protection of Women and Domestic Violence Act, 2005 is a civil law that provides protection to women, from men in the household. It also provides that an aggrieved may also file a complaint against a relative of the husband or the male partner. He told the major section In India there are several legislations for protection of women. Section 125 of the Criminal Procedure Code provides for maintenance of a destitute wife. Section 498 A of IPC is related to mental cruelty inflicted on women by their husbands and in laws. Section 304 B of IPC deals with cases relating to dowry deaths.
